

# About Our Companies

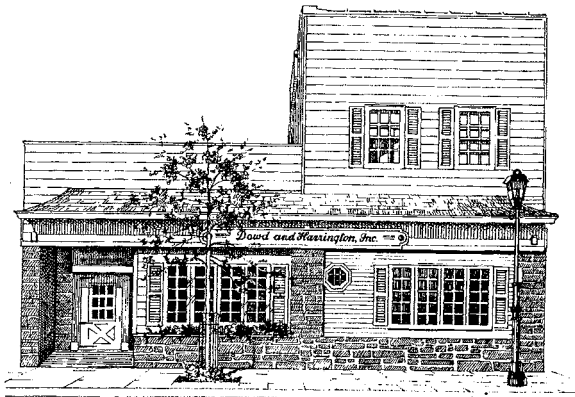
